03. Candidates for Stand Membership shall be proposed by one Club Member and seconded by Another Club Member.
04. Any incorrect information will render the application invalid and liable for rejection.
05. Any omission or inaccuracy in the particulars of the candidate will render election of the candidate void, at the discretion of the Committee of the Management at any time.
06. The Proposer and Secunder should not be in the defaulter List.
07. While signing this application, the candidate accepts that the Committee of Management of Madras Race Club holds the ultimate authority to accept or reject any application without assigning any reasons for the same.
08. Candidates should enclose their latest Bio Data.
09. The admission of Candidate to Stand Membership shall be through election by Ballot by the Club Members of the Madras Race Club.
10. If the candidate receives less than 7 Club Members vote, the ballot is void.
11. A candidate getting more votes in favour than against will be considered/elected.
12. If a Candidate is not elected as per the Ballot, he shall not be eligible for election as Stand Member until after the expiry of six months.
13. A candidate for Stand Membership who is withdrawn during the time the ballot is open for Voting, shall not be again put up until after the expiration of six months.
14. The last date for submission of the Application Form on or before 6.00 P.M. on Monday, 17th February, 2025. The Application fee of Rs. 8000/- shall be adjusted against Entrance Fee to the respective applicant in case he/she is successfully admitted as Stand Member of the Madras Race Club, otherwise it will be refunded.
